## Mission Statement

The Harding Township School provides a strong educational foundation which inspires students to achieve academic excellence. Our dedicated faculty stimulates intellectual growth using a challenging curriculum within a supportive learning environment. We encourage students to become self-directed, lifelong learners who are well prepared for the academic and social challenges of the future.

The 2021-2022 Harding Township School District goals are inspired by and connected to the 2019-2024 Strategic Plan that was developed by key stakeholders.

**District Goal 1:** To identify reentry learning gaps and measure the academic progress of our students through the administration of pre- and post-grade-level assessments in Reading, Math, and Writing that correlate with the NJSLS standards and Reader's/Writer's Workshop Reading progress will be measured by a DRA reading assessment administered to all K-2 students.

- a.) Ninety percent (90%) of all K-2 students will be reading at grade level or will move up a grade level in the post-assessment results. All grade 3-8 students will be assessed using the STAR assessment. Ninety percent (90%) of all students will achieve grade level performance or improve by at least one grade level from their baseline assessment.
- b.) Math progress will be assessed using the Star assessment which will be administered to all grade 3-8 students. Ninety percent (90%) of all grade 3-8 students shall achieve grade level performance or improve by at least one grade level from their baseline assessment.
- c.) Writing progress will be measured by a district developed writing assessment administered to all K-8 students. Ninety percent (90%) of all K-8 students shall improve one point (one quintile) on the grade-level District Writing Assessment in the post-assessment results. Students scoring a 5 shall be counted as having met the goal.

**District Goal 2:** To provide Harding Township students with the social media skills to be safe and responsible digital citizens and learners.

**District Goal 3:** To expand student exploration opportunities, such as (examples), Husky TV, debate, a student newsletter, and other feasible collaborative projects that empower students to become active participants in their learning.

**District Goal 4:** The Harding Township School will continue to address the social, emotional, and recovery needs of all of its members by providing additional opportunities for social emotional learning for students and faculty as well as promoting practices and strategies for wellness.

# **Code of Ethics for School Board Members**

N.J.S.A 18A:12-24.1

- o I will uphold and enforce all laws, rules and regulations of the State Board of Education, and court orders pertaining to schools. Desired changes shall be brought about only through legal and ethical procedures. Read aloud by Mrs. Krikos
- I will make decisions in terms of the educational welfare of children and will seek to develop and maintain public schools that meet the individual needs of all children regardless of their ability, race, creed, sex, or social standing. – Read aloud by Mr. Gjivoje
- I will confine my board action to policy making, planning, and appraisal, and I will help to frame policies and plans only after the board has consulted those who will be affected by them. – Read aloud by Dr. Anastasiou
- o I will carry out my responsibility, not to administer the schools, but, together with my fellow board members, to see that they are well run. Read aloud by Mr. Singh
- I will recognize that authority rests with the board of education and will make no personal promises nor take any private action that may compromise the board. Read aloud my Mrs. Krikos
- I will refuse to surrender my independent judgment to special interest or partisan political groups or to use the schools for personal gain or for the gain of friends. Read aloud by Mr. Gjivoje
- O I will hold confidential all matters pertaining to the schools which, if disclosed, would needlessly injure individuals or the schools. In all other matters, I will provide accurate information and, in concert with my fellow board members, interpret to the staff the aspirations of the community for its school. — Read aloud by Dr. Anastasiou
- o I will vote to appoint the best qualified personnel available after consideration of the recommendation of the chief administrative officer. Read aloud by Mr. Singh
- I will support and protect school personnel in proper performance of their duties. Read aloud by Mrs. Krikos
- I will refer all complaints to the chief administrative officer and will act on the complaints at public meetings only after failure of an administrative solution. – Read aloud by Mr.

Madison has postponed their referendum until September 2023. HTS has begun the process of determining the expense for a new roof for the Elementary School. HTS will also be working to replace the existing ramp at the Middle School. An update to the LRFP will be given by Dr. Spelker at the April 17<sup>th</sup> BOE Meeting. A number of inflationary expenses (health insurance, busing etc.) have become clearer over the past few months which will undoubtedly have a negative affect on the District's 2023-2024 budget. Dr. Spelker also mentioned that 7 new students joined the District on January 3, 2023.
- b. Business Administrator John Jennings discussed FF-001 and FF-002 with the Board. He noted that while Chapter 44 was intended to save money for both School Districts and employees, it has actually resulted in an increase in costs to the District given lower employee contributions.
