Mission Statement

V. PRESENTATION

Patriot Pen Essay Award, Mr. John Titterton, Commander Watnong VFW *Henry Humphreys, Sophie Jarbath, Francesca Rosato

Dr. Spelker introduced Mr. Titterton. Mr. Titterton spoke about his naval service and how he became involved in the Watnong VFW. He discussed the Patriots Pen and Voice of Democracy programs where he hoped to get more students, specifically high school students involved. He introduced the

three winners of the Patriot Pen Program; Francesca Rosato third place, Sophie Jarbath second place and Henry Humphreys first place. He read and presented the awards to Francesca and Sophie. Mr. Gjivoje thanked Mr. Titterton for his service to the country.

START Strong Results – 2022, Mrs. April Friedman, Principal/Dir. Of Curriculum

Mrs. April Friedman, Principal and Director of Curriculum presented the Harding Township School Start Strong Assessment (SSA) results for 2022 to the Board. She noted the primary purpose of the SSA was to provide instructional information about students' needs for additional support following the disruption to education due to the Covid-19 pandemic. She also mentioned that because the SSA was administered at the beginning of the year to provide rapid feedback to schools and because it is based on a subset of student learning standards, SSA only includes machine-scored selected responses. SSA is meant to reveal conceptual or skill gaps that can be addressed moving forward. Mrs. Friedman then reviewed the results with the Board, comparing the 2022 results to the 2021 results. She noted the 2022 SSA results saw a marked improvement across grade levels and subject levels for both regular education and special education students. She also mentioned that most of the data revealed was information Administration/Teachers already knew about our students' abilities. Focus continues to be on academic stamina, independence, problem solving abilities and strong academic habits. Mr. Gjivoje commented on the strong results of the District and noted they were way ahead of the overall State results. Mrs. Krikos asked how these results compare to the NJSLA test results? Dr. Spelker mentioned the District began using the Link-it program that draws information from their test results to provide detail assessment information on a student level. Mr. Gjivoje and Mr. Bruno thanked the faculty and administration for the strong results.

- f. Madison Board of Education, 1/17/23 Mr. Bruno noted that at the Madison Reorganization meeting, the vote for Board President ended in a tie. The Morris County Executive Superintendent interviewed 3 candidates and selected Sarah Fischer as the Madison BOE President. Mr. Bruno mentioned he brought up the calendar anomaly (Harding and Madison both holding their 2024 BOE reorganization dates on the same day/time). He stated this topic was tabled by the Madison Board. He also mentioned that there has been continued focus by the Madison BOE on Transgender Education. Dr. Spelker speaking on his own accord as a Madison, NJ resident, mentioned that what happened to Mr. Bruno at the Madison Reorganization BOE meeting on January 3, 2023 was unacceptable. He noted Mr. Bruno handled it with class and he thanked Mr. Bruno for his continued support of the Harding School District. Mr. Gjivoje echoed Dr. Spelker's comments. He also noted he found it peculiar that the Madison BOE challenged Mr. Bruno's right to vote at the Madison Reorganization meeting this year even though Mr. Bruno previously voted as Harding's representative in both of the last two years (as did prior HTS representatives, in prior years). Mr. Gjivoje mentioned that the send/receive relationship with the Madison School District is by mutual consent, made every 5 years or so per contract.
- g. Climate and Culture Dr. Anastasiou noted that the Family Game Night event was well attended and approximately \$1,000 was raised. He also mentioned that he hoped for more future events/participation as the pandemic restrictions have loosened.

Johanna Habib of Madison, NJ commented that she was a previous member of the Madison BOE. She mentioned she had disdain for the events at the January 3rd Madison BOE reorganization meeting and is concerned with the Long-Term relationship between Harding and Madison School Districts and she hopes it remains in good shape. She asked that the Harding BOE be open-minded about the events that happened. She noted that, while Harding has the right to maintain a seat on the Madison Board, the Harding representative has limited experience/information regarding the Madison School District, he does not walk the hallways of the school, he does not shop in the stores in Madison, he does not sit on Committees and he was not elected by the residents of Madison. She apologized to Mr. Bruno for her comments at the January 3rd Madison BOE meeting, and she hoped

that the Harding BOE could move past the events of January 3rd. Dr. Spelker, speaking for himself, noted that he grew up in Madison, currently resides in Madison, shops in Madison, graduated from

Madison High School and has a very good working relationship with the Madison Superintendent. He noted that Mr. Gjivoje, Harding's BOE President, graduated from Madison High School and was, to his recollection, the Salutatorian. Mr. Gjivoje thanked Johanna Habib for her comments. He stated that it is very clear, via NJ Statue, that Harding Township has a right to have a representative on the Madison BOE and that this same representative has the right to vote for the Madison Board President, and all other Officers of the Madison BOE. Mr. Gjivoje also highlighted and re-iterated that the HTS-Madison "Send-Receive Relationship" is a relationship of "mutual choice"; neither party is obligated to "send" or to "receive", unless the parties agree by mutual written consent.
