#### Mission Statement

The Harding Township School provides a strong educational foundation which inspires students to achieve academic excellence. Our dedicated faculty stimulates intellectual growth using a challenging curriculum within a supportive learning environment. We encourage students to become self-directed, lifelong learners who are well prepared for the academic and social challenges of the future.

The 2019-2020 Harding Township School District goals are inspired by and connected to the 2019-2024 Strategic Plan that was developed by key stakeholders.

**District Goal 1:** To measure the academic progress of our students through the administration of district-wide assessments in Reading, Math Facts, and Writing that correlate with the new NJSLS standards and Reader's/Writer's Workshop.

- a. To administer a district-wide reading assessment to all K-3 students in the spring. Ninety percent (90%) of all students will be reading at grade level or will move up a grade level.
- b. Ninety percent (90%) of students in each grade, K-5 shall pass, with 90% accuracy, a grade-level revised "Math Facts Assessment." This "Math Facts Assessment" shall be aligned to the NJSLS and will assess students on the four core mathematical functions (addition, subtraction, multiplication and division).
- c. Ninety percent (90%) of students in grades K-8 shall improve one point (one quintile) on the revised District Writing Assessment. The rubric scores for this assessment range from 1.0 to 5.0. This assessment shall be administered in the fall and in the spring. Students scoring a 5.0 in the spring shall be counted as having met the goal.

**District Goal 2:** To continue to create a STEM program and STEM facility for the Harding Township School that meets the needs of all of its students.

**District Goal 3:** To draft a five-year plan for critical/essential facilities upgrades.

**District Goal 4:** All faculty members and administrative staff will engage in reflective practices and collaborate to develop further a personalized learning environment, through relevant professional development experiences, and through other learning and collaborative methods that build on this goal.
