Dr. Chris Mango, Director of Student Services presented an overview of the Special Education

Services provided by the Harding Township School District to the Board. Dr. Matthew Spelker, Superintendent reviewed the QSAC scores with the Board of Education. He noted they would be posting the results on the website.

- a. Superintendent Dr. Spelker noted the following: Faculty and staff will be returning to HTS on 8/31 and 9/1 for Professional Development. First day of school is Tuesday 9/6. HTS Barbeque will take place 9/16. HTS back to school nights will take place on 9/20 Middle School and 9/21 Elementary School. Work on the Middle School HVAC project began the end of June. Six of the seven spaces should be working and online for the opening of school. The final classroom is expected to be completed the following week.
- b. Business Administrator John Jennings noted FF-024 motion to accept Alyssa's Law Grant of \$20,000 was for reimbursement of Security upgrades completed in 2021. He noted FF-025 Emergent and Capital Maintenance Grant would be used for the Middle School HVAC project. He noted that FF-026 FF-029 is for non-public school aid that we receive from the State for the benefit of a non-public school in the township. He mentioned the non-public school aid has no effect on the District's State Aid. Any money not used by the non-public school is refunded to the State.
- c. Madison Board of Education Mr. Bruno noted there was an 8/23 meeting. He mentioned the Madison Board passed a resolution regarding Athletic participation on Religious Holidays that allows for individual students to miss practice in observance of Religious Holidays. He also noted the next meeting is on 8/30.
